	TS opened the meeting at 10.30 am and thanked everyone for their time. GW confirmed that the meeting was quorate in line with the Trust's Article 117. TS stated that agenda item number 2, the appointment of KY as Interim Chair of Dawlish College, was as a result of resignation with immediate effect of David Violett who is a co-opted governor and has been Chair.

22/4/2.2	<b>Appointment of Katie York as interim Chair of Governors at Dawlish College:</b> TS thanked KY for stepping in as interim Chair and explained that there are five new governors coming into the LGB at Dawlish, some of whom are inexperienced and will require training and bringing up to speed so this is very much an interim appointment while that takes place. It was also noted that a co-opted governor resigned yesterday but this will be covered at the Full Board on 15 December. TS proposed, SJ seconded, unanimously agreed and duly <b>APPOINTED</b> .

22/4/2.4	Assignment of Chairs' Actions as follows:	
	<ul> <li>The CEO in consultation with the Chair of the Trust Board</li> <li>The Headteacher in conjunction with the CEO and the Chair of the LGB</li> <li>GW explained that this was within the Scheme of Delegation and required assignment from Trustees for use where an urgent decision is required in the interests of the Trust and there is insufficient time to convene a meeting of the Trust Board or LGB, this gives the CEO and the Headteacher of the relevant academy delegated powers to make urgent decisions. An urgent decision is one where a delay would be likely to be seriously detrimental to the interests of the Trust, any pupil at a school within the Trust, or their parent, or a member of staff. TS confirmed that he would always seek to consult another Trustee if that was the case. Trustees discussed whether the assignment of Chairs' Actions should be reviewed in the event of a change of person within one of the roles and it was agreed that the appointed Chair and CEO would receive the total confidence of the Board. TS proposed, BF seconded, unanimously agreed and duly <b>ASSIGNED</b>.</li> </ul>
